## 2008 MEDICAID COMMUNITY SPOUSE RESOURCE LEVELS

On January 1st of each calendar year, adjustments are made to some of the public benefits numbers in accordance with adjustments in the cost of living index. The following Medicaid numbers reflect the 2008 levels (effective January 1, 2008):

### Medicaid Income Levels:

For a Single Individual      \$1,911

### Medicaid Resource Levels:

For a Single Individual      \$2,000  
For a Community Spouse      \$104,400  
For a Married Couple      \$3,000

### Community Spouse Monthly Needs Allowance:

Minimum: \$1,711.25\*      Maximum: \$2,610

\* Effective July 1, 2007.
